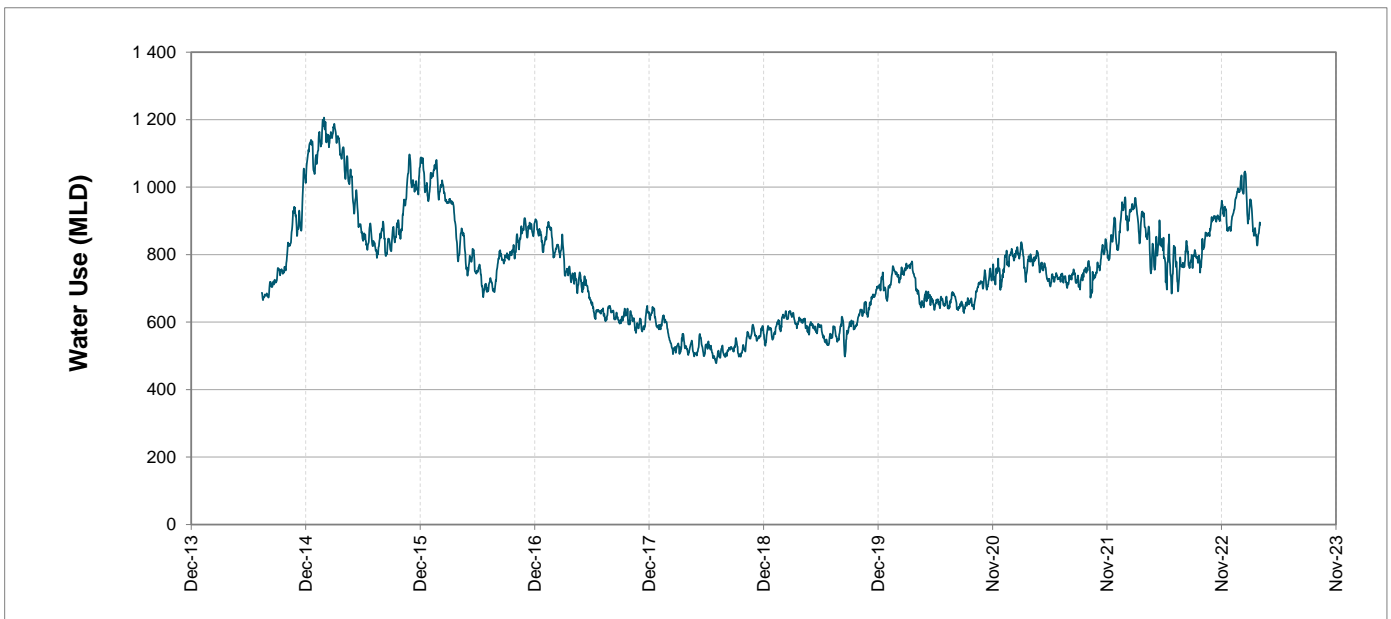
### Water Resource Status

WATER RESOURCE STATUS	MEANING OF CURRENT STATUS
Early Drought Caution	There is a strong indication of a possible, but not confirmed, drought cycle developing or continuing from the record low rainfall levels between 2015-2017. It is important to continue using water wisely. There is no immediate cause for concern about water security in Cape Town. However, it is the responsible step to take now for Cape Town to collectively aim not to exceed a target of 850 millions of litres per day (MLD) to lower the risk of restrictions at a later stage.

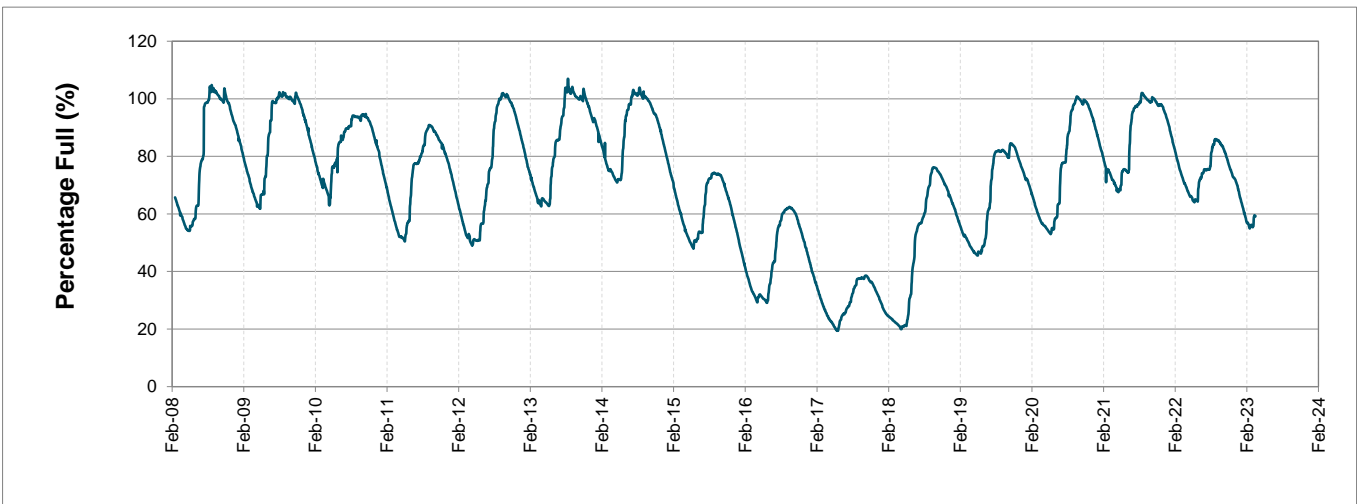

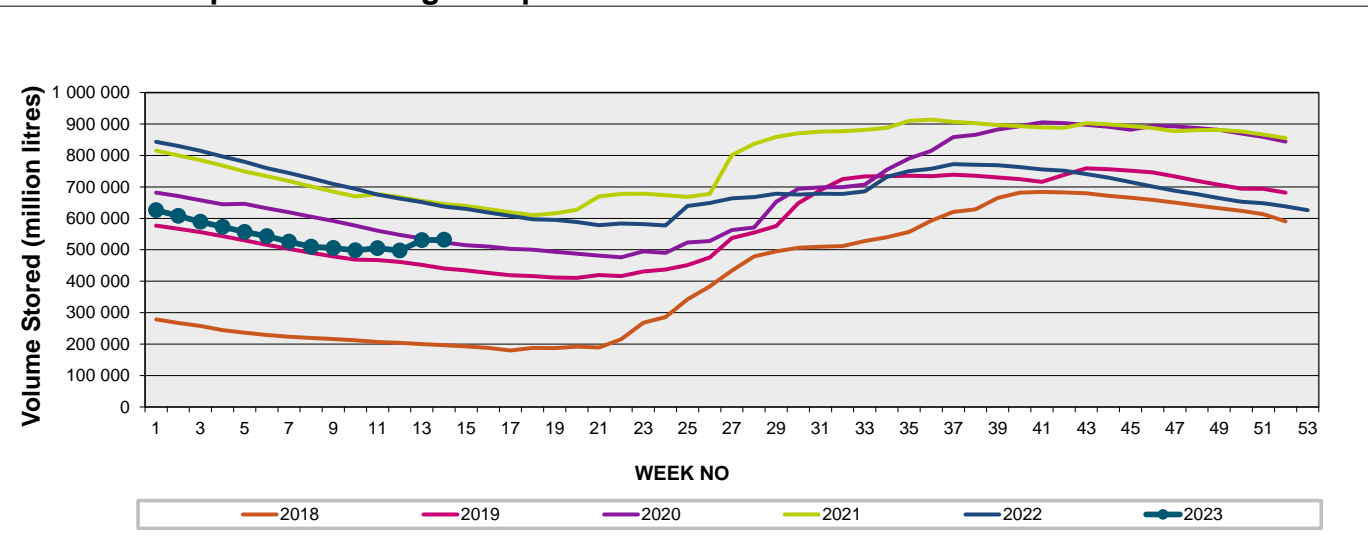

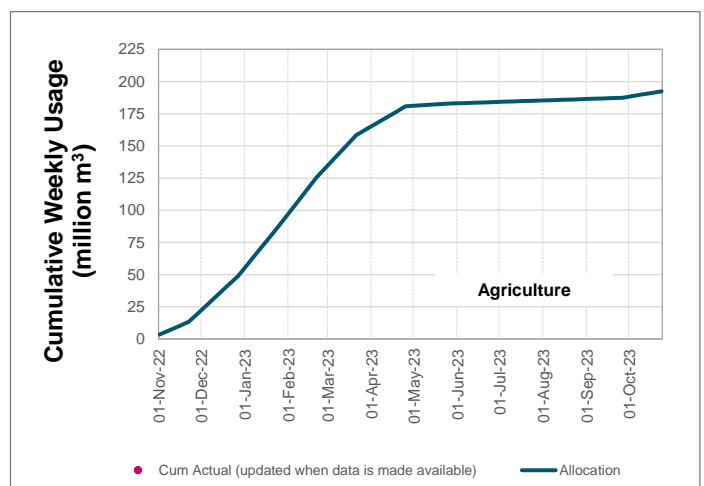
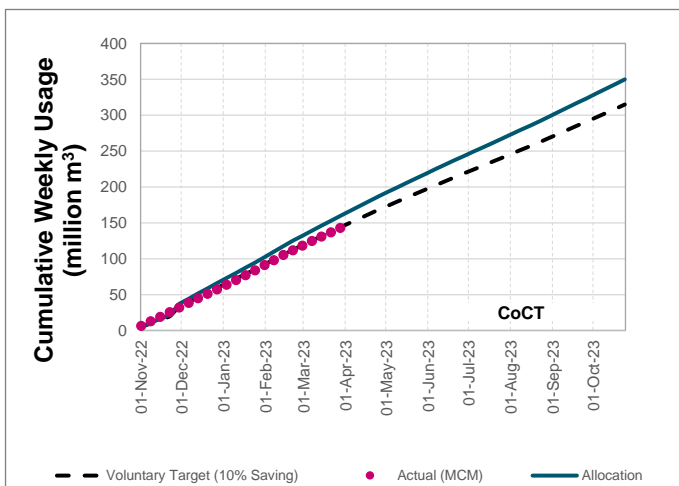
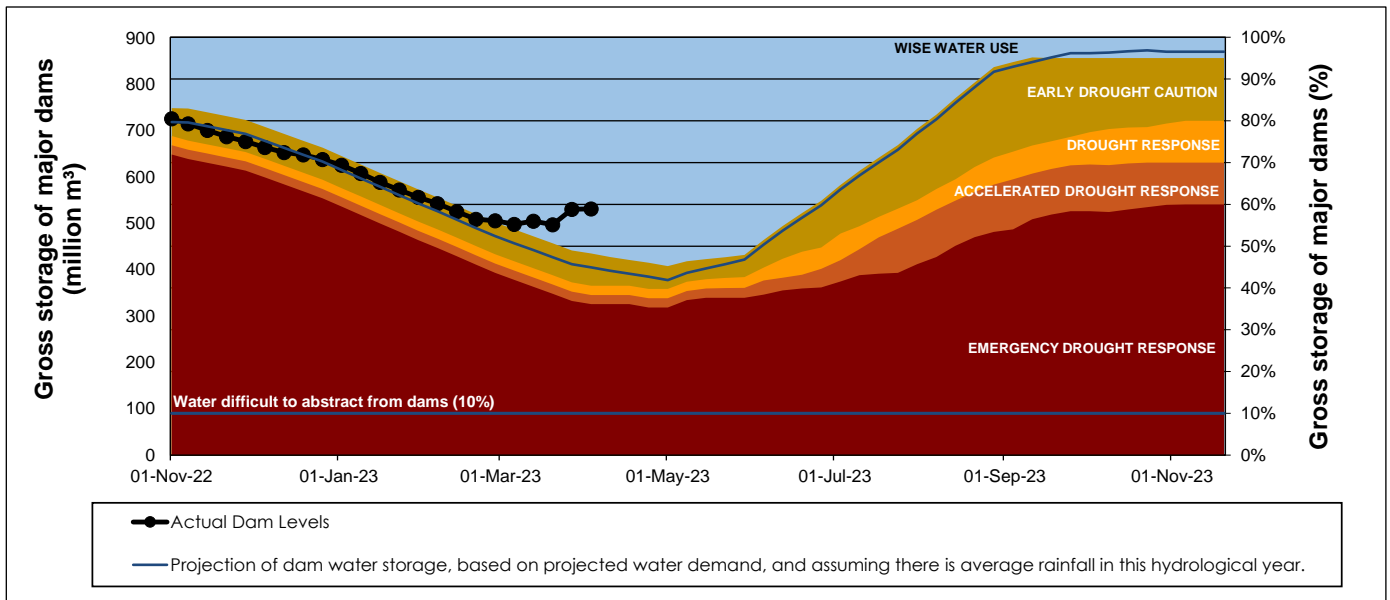
## WCWSS Storage Record (2008 - Present)

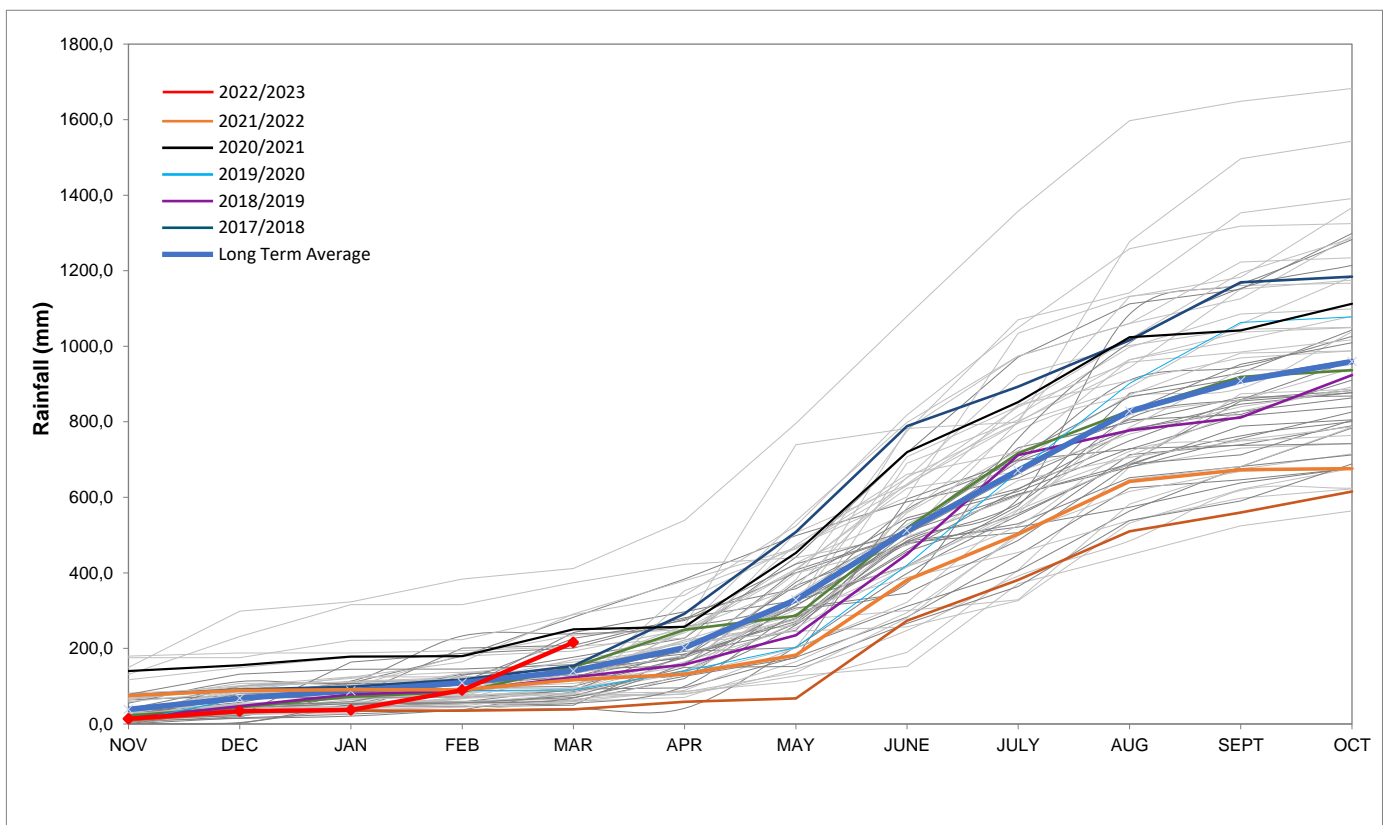

This table shows CCT drinking water quality compliance according to the South African National Standard 241:2015. Compliance, measured against all prescribed chemical and microbiological components, consistently exceeds the very high CCT target of 98.5%.
